



TERM AND CONDITION
“PAY WITH SAMSUNG PAY”
PROMOTION

(This Term and Condition is effective from 20/07/2020)

1. The “Pay with Samsung Pay” Promotion (“Promotion”) shall be effective from **20 July 2020 to 30 August 2020** (“Promotion Period”).

2. Applicable customers:

2.1 HSBC Credit Card Cardholders (“Cardholders”) issued by HSBC Bank (Vietnam) Ltd. in Vietnam (“Bank” or “HSBC”):

- HSBC Premier World Mastercard® Credit Card
- HSBC Visa Platinum Credit Card
- HSBC Visa Cash Back Credit Card
- HSBC Visa Classic Credit Card

(“HSBC Credit Card”)

2.2 Cardholders who use Samsung devices supported Samsung Pay apps

2.3 Cardholders will not be eligible for this Promotion if his/her HSBC Credit Card is delinquent, blocked with any reason.

2.4 Cardholders are not HSBC Business Credit Card Cardholders

2.5 Cardholders are not HSBC’s staff

3 Promotion Details:

3.1 Offers details:

- Get cashback of VND 100,000 when you spend VND 200,000 or above with your HSBC Credit Card using Samsung Pay, within 7 days of successfully registering to the Promotion
- The Promotion is applied for first 900 Eligible Cardholders during Promotion Period.
- Reward timeline:

Registration date	20/07/2020 – 30/08/2020
Spending date	7 days since registration date
Posted date on HSBC system no later than	12/09/2020
Cashback reward date no later than	30/09/2020

3.2 How to apply:

- Step 1: Cardholders install Samsung Pay apps on their compatible Samsung device and link your HSBC Credit Card with Samsung Pay app
- Step 2: After successfully linking your HSBC Credit Card, Cardholders need to register for the Promotion by clicking on the promotion banner on Samsung Pay app and fill the required information.
- Step 3: Spend with HSBC Credit Card using Samsung Pay within 7 days of registration date

3.3 Cardholder needs to register for the Promotion for one (01) time during Promotion Period. The mobile phone number/email address registered for the Promotion must be recorded with HSBC.

3.4 Each Eligible Cardholder will only receive one (01) reward during Promotion Period. The reward notification will be sent by HSBC to Eligible Cardholders by SMS/email.

3.5 The Promotion is applied for Primary Credit Cardholders and Supplementary Credit Cardholders. However, the reward will be credited to the Primary Cardholder's account.

3.6 Eligible Transactions (“**Eligible Transaction**”) are transactions made by HSBC Credit Card via Samsung Pay apps at Point of Sales machine (POS) and do not include online transactions. Eligible Transactions does not include transactions relating to alcohol, cigarette and other promotion restricted products. Eligible transactions do not include transactions relating to alcohol for customers under 18 years old.

3.7 Cancelled/ reversed transactions within or after the Promotion Period will be excluded from the Eligible Transactions. HSBC reserves the right to deduct the reward amount once cancellations, if any.

3.8 The reward will be presented to Cardholders first come first serve bases, based on record of HSBC.

3.9 HSBC will consider the transaction date and posting date as recorded by HSBC's system and shown on credit card statements of cardholders to define the Eligible transactions.

Note: The SMS notification about the transaction completion does not mean that the transactions posted in HSBC system.

3.10 Eligible Cardholders are excluded from receiving the reward if the Eligible Cardholder is in the process of closing their card before/on the reward date.

3.11 In case the Eligible Cardholders qualifies for the reward but does not receive it, they need to contact HSBC for further assistance.
