



TERMS AND CONDITIONS

“OFFER FOR FORBES VIETNAM ANNUAL SUBSCRIPTION FOR HSBC PREMIER WORLD MASTERCARD® CREDIT CARDHOLDERS” PROGRAMME

Customer is advised to note that participating in the programme shall mean that Customer has read, understood and accepted these Terms and Conditions.

1. ELIGIBILITY

- Using HSBC Premier World Mastercard® Credit Card (“**Card**” or “**HSBC Credit Card**”) issued by HSBC Bank Ltd. (Vietnam) (“**HSBC**”) in Vietnam.
